1. Be a Canadian citizen residing in Canada.
2. Be at least 18 years of age and have known you for at least two years.
3. Hold a valid Manitoba driver's licence or identification card at time of application and have held same at least 2 years.
4. Fully complete the Declaration of Guarantor section below.
5. Initial any and all changes and corrections made to information provided as part of this declaration.
6. Friends and family may be your Guarantor if they meet the other Guarantor requirements listed above.

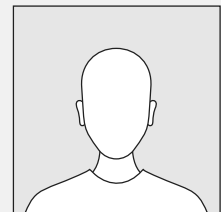

Selecting an Applicant Photo*

Applicant photo **MUST**:

- Be available when this form is completed in the presence of the Guarantor.
- Have been taken within the last 3 months.
*Photos or photocopies of previous Applicant photos or ID are **NOT** acceptable.*
- Have a neutral facial expression.
- Have a plain background.
- Show Applicant from shoulders up with facial features clearly visible.



Applicant photo **CAN** be:

- a. a passport photo,
- b. a store printed photo, **OR**
- c. a photo taken and printed by the Applicant.

**Photos are required ONLY if the Guarantor form is used to support the photo requirement.*
